## **The Lakecrest Forest and Lakecrest Village Homeowners Association Inc. (“HOA”)**

- The HOA is professionally managed with attention to detail for rules enforcement, architectural control and community programs.
- All residential property within the Lakecrest Communities is subject to the Declaration of Covenants, Conditions and Restrictions for Lakecrest Forest recorded in the Office of the County Clerk of Harris County, Texas, under Clerk's File No. Z416604 and any amendments or supplements thereto; Declaration of Covenants, Conditions, and Restrictions for Lakecrest Village recorded in the Office of the County Clerk of Harris County, Texas, under Clerk's File No. Z416605 and any amendments or supplements thereto; and Declaration of Annexation and Supplemental Declaration of Covenants, Conditions and Restrictions for Lakecrest Park Section One recorded in the Office of the County Clerk of Harris County, Texas, under Clerk's File No. 20130591238 and any amendments thereto (collectively, the “Restrictions”)
- Each Owner should thoroughly read and understand the Restrictions and the rights of the HOA to enforce the provisions thereof and to assess each Owner with different assessments, fees and charges. Each Owner should note the specific rights of the Declarant (as defined in the Restrictions) who maintains substantial unilateral rights during the Development Period (as defined in the Restrictions). The Declarant appoints the Board of Directors of the HOA during the Development Period.

## **2014- HOA -Rates of Assessments and Other Charges**

- The 2014 Annual Assessment (as defined in the Restrictions) for The Lakecrest Communities is \$495.00. The Annual Assessment is used for the operation, management, expenses and maintenance of the Association for the following 12 month period and is due in January of the year (in advance) for the year it is assessed. New homeowners may pay a prorated amount for the period of the year that they will own the residence at the closing thereof.
- The 2014 Capital Assessment (as defined in the Restrictions) is \$247.50. A Capital Assessment of 50% of the current year's Annual Assessment will be collected at closing and this fee is not prorated. This is a one time fee for each and every buyer of a residence paid at each closing thereof. This Capital Assessment may be used by the HOA to defray operating costs, capital improvement costs and other expenses of the HOA.
- A Specific Assessment (as defined in the Restrictions) for the Lakecrest Park neighborhood (only) will be collected on an annual basis for 2014 for mandatory community front yard lawn maintenance at an annual cost of \$ 640.00 per lot and such amount shall be due in advance for the calendar year.

- Other charges including but not limited to fees, late fees, penalties, or fines are either set by the Board of Directors or outlined in the Restrictions as applicable.

## **HOA Front Yard Maintenance Program**

## **HOA Amenities**

- In The Lakecrest Communities certain amenities may be developed as the community matures as a part of a flexible master-plan.
- Lakecrest Forest, Lakecrest Park and Lakecrest Village which are all part of the HOA and share common amenities such as the following:
  - Community Trails
  - Community Parks
  - Aquatic Center with pool and playgrounds (located in Lakecrest Forest).
- Lakecrest Forest, Lakecrest Park and Lakecrest Village (“The Lakecrest Communities”) which are all part of the same HOA, share a common management company and a common community budget; however, certain Architectural Guidelines, Supplemental Deed Restrictions may vary by neighborhoods within The Lakecrest Communities.
- The Lakecrest Communities do not include the Lakecrest subdivision located South of Franz Road and any amenities within that subdivision.
